Ministry Planning for Coronavirus (COVID-19)

Management discussed the memo sent by the Secretary of the Cabinet on March 24 2020 regarding critical service work. Management is currently working with Senior Management to determine what staff will be performing critical service work within ENDM worksites.

The Union expressed they are pleased with how ENDM is handling this situation.

ENDM only has 2 time critical services (less than 1 week) listed within the Continuity of Operations Plan (COOP). There are other critical services, identified within the NDM Recovery Plan, with recovery strategies within 1 month.

The Union raised concern that not all staff have VPN access. Management has confirmed they are working on getting this resolved. A bulk order has been placed to equip staff. Staff are being encouraged to utilise Office365 as best they can. Work is being done to ensure staff no longer need to come in and out of the office to access files and information.

The Union raised concern with fixed-term employees contracts coming due during this time. The Union would support short term extensions if needed to retain contract staff, with the expectation that a competition, per the collective agreement, is run when this situation is over. ENDM's staffing approval process will continue and managers are assessing their staffing needs on a case by case basis through the current COVID-19 situation.
