Minutes of the OPSEU/SEFPO Convention 2023 April 20-22, 2023 Metro Toronto Convention Centre, Toronto

Equity Update

Equity All-Chairs Committee Chair Taylor Phillips, L116 came to the stage to present the OPSEU/SEFPO Equity Report.

Peter Thompson, L154 Chair of the Coalition of Racialized workers introduced the All-Chairs Committee

Peter introduced 5 calls to action that all members and all locals should engage with in order to support the goal of strengthening equity in OPSEU/SEFPO, and in our communities. These include:

- 1. Attending non-union community events like Pride, Caribana, the Grassy Narrows River Run, the Ontario Francophone Festival, Special Olympics, International Women's Day Marches, etc.
- 2. Attending Area Council meetings.
- 3. Creating safe spaces for promoting equity in locals. This could include creating local equity officer and other equity positions.
- 4. Supporting and attending equity campaigns, conferences, and events. Joining or holding events in support of equity groups. Encouraging all members to sign up and attend equity events.
- 5. Ensuring the continue strength and growth of equity committees by identifying natural leaders and engaging in succession planning.

As the Chair of the Ad-Hoc committee on Equity Seats, Taylor then introduced the social mapping presentation and the equity seats conversation. This conversation included a video produced by the Ad-Hoc committee.

President JP Hornick thanked the Ad-hoc Committee and all the Equity Committees for their hard work.

Ontario NPD leader, and leader of the Official Opposition, Marit Stiles and Canada's NDP Leader Jagmeet Singh were introduced and spoke to Convention.

Ontario NDP Leader Marit Stiles spoke to the assembled convention and recognized the work OPSEU/SEFPO members do organizing, mobilizing, and engaging in struggle for workplace and social justice. Marit went on to describe an Ontario that is failing its citizens and how this is something we're all feeling. She argued that for five long years Doug Ford has been at war with workers. As the new leader of Ontario's NDP, Marit committed to stand in solidarity with workers in every single step in the struggle against Doug Ford and his government.

Federal NDP Leader Jagmeet Singh spoke to the assembled convention and acknowledged the work that OPSEU/SEFPO members are doing in their communities fighting for a better province and a better country. Jagmeet laid out his vision for Canadians, a vision that includes a country where people have good jobs, can afford to pay their bills, can fill their fridges with affordable and healthy food, and where they don't have to worry about finding a home that's in their

budget. Jagmeet will fight for a Canada where every Canada gets the health care they need, no matter how much they earn or where they live. Jagmeet concluded by reminding the convention that when workers come together, workers have incredible power and that when workers organize, when workers fight, we all win.

President JP Hornick welcomed our Solidarity Guests.

Amend the below sections of Article 13, 14, 15 and 19 to read as follows:

Article 13 CONVENTIONS

However, if a discrepancy arises between Headquarters and Local records which would affect the delegate entitlement of a Local, upon providing sufficient proof a Local shall be entitled to any extra delegate to which its Local records may entitle it.
